Prayer in W.P.No.10247 of 2010: forbearing the respondents from interfering with the peaceful possession and enjoyment of the petitioner's property bearing Plot No.5 to an extent of 2862 Square feet comprised in Old Survey Number 181/16 and as per Sub-division Survey No.181/16F as per Patta No.2028 situated at Peerkankarai Village, Tambaram Taluk, Kancheepuram District.

Prayer in W.P.No.10248 of 2010: forbearing the respondents from interfering with the peaceful possession and enjoyment of the petitioner's property bearing Plot Nos.3 and 2 (Part) to an extent of 2860 Square feet and 1430 Square feet respectively comprised in Survey Number 181/16C in Old Survey No.181/16 in Old Patta No.2026 and 2025 New Patta No.2212 situated at Peerkankarai Village, Tambaram Taluk, Kancheepuram District.

Prayer in W.P.No.10249 of 2010: forbearing the respondents from interfering with the peaceful possession and enjoyment of the petitioner's property bearing Plot No.4 to an extent of 2862 Square feet comprised in Old Survey Number 181/16 and as per Sub-division Survey No.181/16E as per Patta No.2027 situated at Peerkankarai Village, Tambaram Talum, Kancheepuram District.

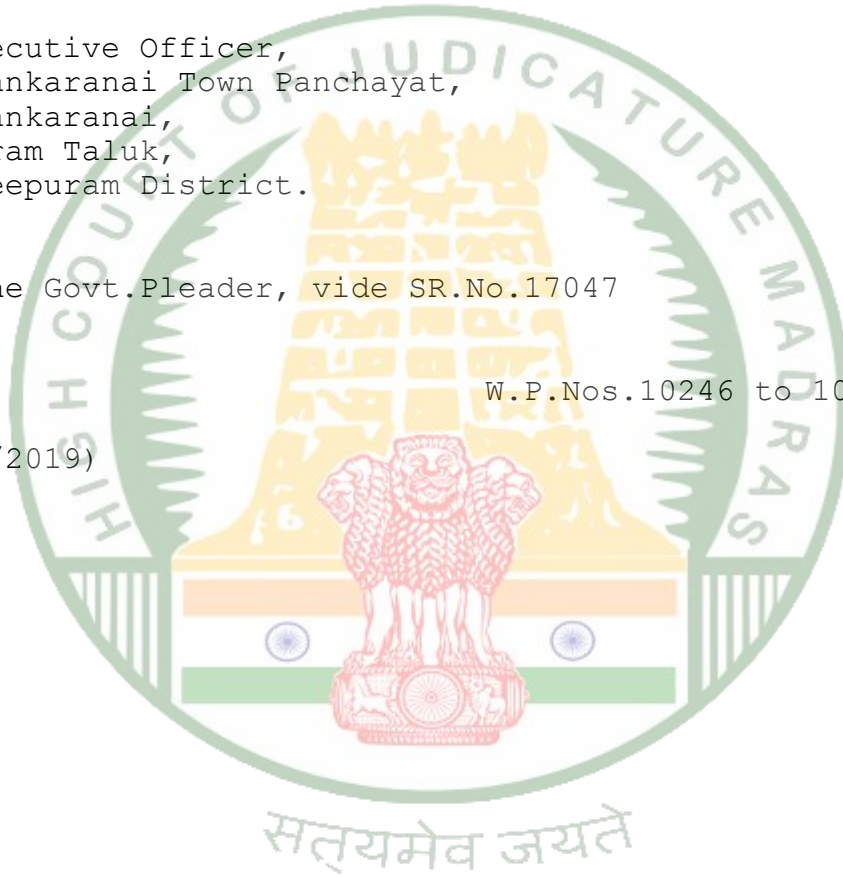
