As against the termination order passed by the 3rd respondent herein, a revision alone is maintainable, in view of the Judgement of a larger Bench of this Court reported in 2006 (4) CTC 689 in the case of K.Marappan vs Deputy Registrar of Co-operative Societies, Namakkal and another).

2. In view of the same, the present writ petition is disposed of, with a liberty to the petitioner to approach the authority, under Section 153 of the Tamil Nadu Co-operative

Societies Act. On receipt of such a revision, the revisional authorities shall dispose of the same on its own merits, subject to the law of limitation.

3. No costs. Consequently, connected Miscellaneous Petition is closed.
