Kangayam and Vellakoil to use the old bus stand as per the permit taking the existing course of the permitted route.

No.27404 OF 2008 : Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondents continue to permit the bus of the petitioner bearing Registration number TN 47/Q 9767 or any other vehicle that will replace those vehicles in future on the route Tirupur to Pallapatti and Tirupur to Karur via. Kangayam and Vellakoil and to use the old bus stand as per the permit taking the existing permitted course of the route.
