2. 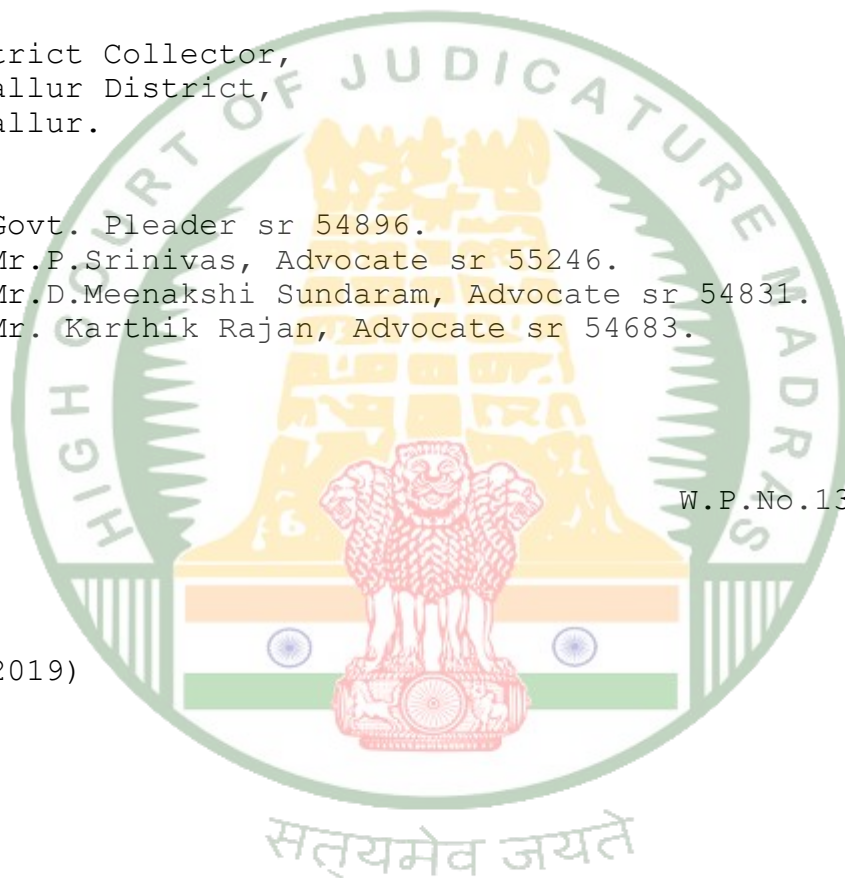
