The learned counsel for the petitioner would submit that for the purpose of securing the poromboke land, the petitioner was asked to evict from the premises and she was informed that an alternative site to an extent of 360 sq.ft., would be provided. The learned counsel would further submit that the proposal for providing alternative site is pending before the Government.
