Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus directing the respondents to issue transport permit to transport the quarried granite on payment of necessary seigniorage in respect of granite quarry measuring 0-62-3 Hectares, comprised in Survey No.301/2 (part) 0-15-0 Hectares comprised in Survey No.301/3 (part), 0-44-5 Hectares comprised in Survey No.301/4 (part) 0-14-2 Hectares in Survey No.302/1B (part) totally measuring 1-36-0 Hectares situated at Punjai Edayar West Village, Paramathi Velur Taluk, Namakkal District till the disposal of the petitioner's renewal application dated 14.09.2005.
