(i)Writ of Certiorarified Mandamus, to call for the records of the impugned proceedings dated 31.12.2018 passed by the third respondent and quash the same and consequently, direct the third respondent to fix a fair rent to the premises under the petitioner's occupation, which belongs to the Arulmighu Vellai Pillayar Kovil, Attur, Salem District in consultation with the petitioner in reasonable manner in order to continue the tenement by the petitioner.[W.P.No.2626, 2630, 2632, 2633, 2637, 2704, 2708, 2710, 2713, 2716, 2774, 2778, 2779, 2782,of 2019]

ii)Writ of Mandamus forbearing the 3rd respondent from taking coercive steps of eviction or dispossession as against the petitioner from the premies D.No.563 564 with an extent of 1275 sq.ft. which belongs to the Arulmigu Vellai Pillayar Kovil Attur Salem District and consequently direct the 3rd respondent to fix a fair rent by giving opportunity to the petitioner based on the representation on 26.12.2018. [W.p.No.3724 of 2019]

iii)Writ of Mandamus forbearing the 3rd respondent from taking coercive steps of eviction or dispossession as against the petitioner from the premies D.No.565 566 with an extent of 1242.75 sq.ft. which belongs to the Arulmigu Vellai Pillayar Kovil Attur Salem District and consequently direct the 3rd respondent to fix a fair rent by giving opportunity to the petitioner based on the representation on 26.12.2018. [W.P.No.3727 of 2019]

iv)Writ of Mandamus forbearing the 3rd respondent from taking coercive steps of eviction or dispossession as against the petitioner with respect to the premises D.No.573 with an extent of 1625 sq.ft. which belongs to the Arulmigu Vellai Pillayar Kovil Attur Salem District and consequently direct the 3rd respondent to fix a fair rent by giving opportunity to the petitioner based on the representation on 13.09.2018. [W.P.3730 of 2019]

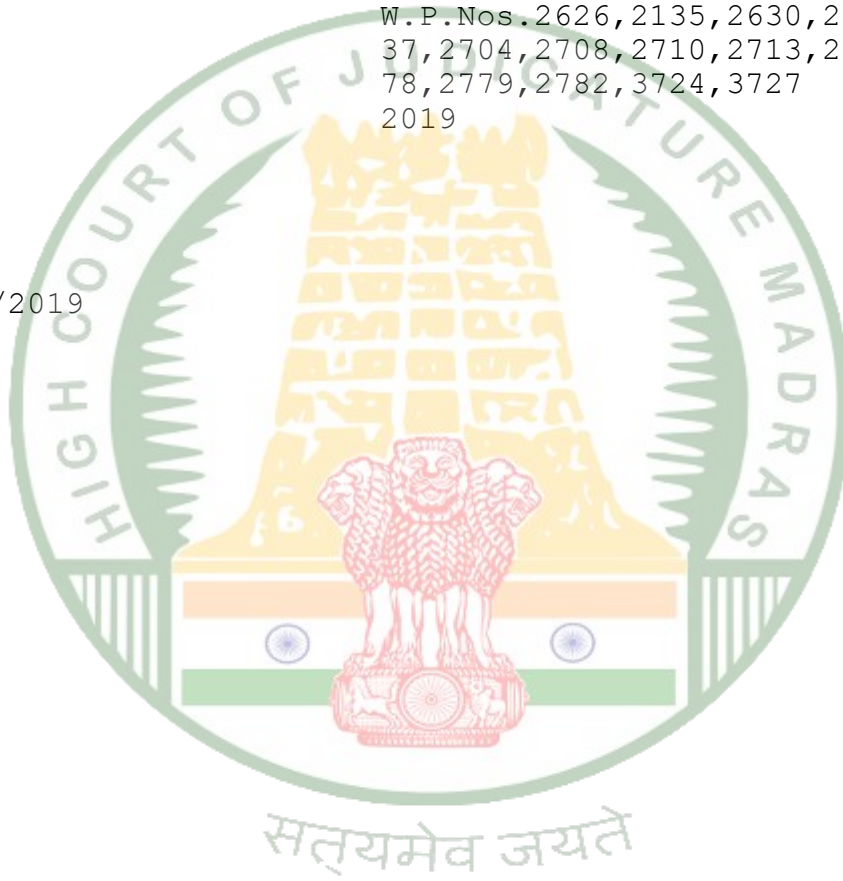
