PRAYER: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus, calling for the records of the 2nd Respondent and 3rd Respondent culminating in the 3rd Respondent's Letter R.D.Hq.L.B.C. No. 0430/2011 dated 27.04.2011 and quash the same in so far as they pertain to the demand for submission of (i) the Notarized Sworn Affidavit in the present format and (ii) the " photocopy of the Property Tax paid receipt upto date" along with

the Application for Trade licences submitted by Traders carrying on trade and business from within and on the periphery of Chennai Municipal Limits and consequentially direct the Respondents 2 & 3 to receive and process the Trade Licence Applications and Trade Licence Fees from Traders and businessmen carrying on trade and business from within and on the periphery of Chennai Municipal Limits without insisting upon (i) the Notarized Sworn Affidavit in the present format and (ii) the "photography of the Property Tax paid receipt upto date" along with the Application for Trade licences.
