In the said representations, the petitioner has prayed that he should not be evicted from the premises, which, according to him, has been declared as a slum by the Tamil Nadu Slum Clearance Board. The premises in question is situated at Door No.15, Southern Side of Elango Street, Govindaswamy Nagar, R.A.Puram, Chennai 600 028.

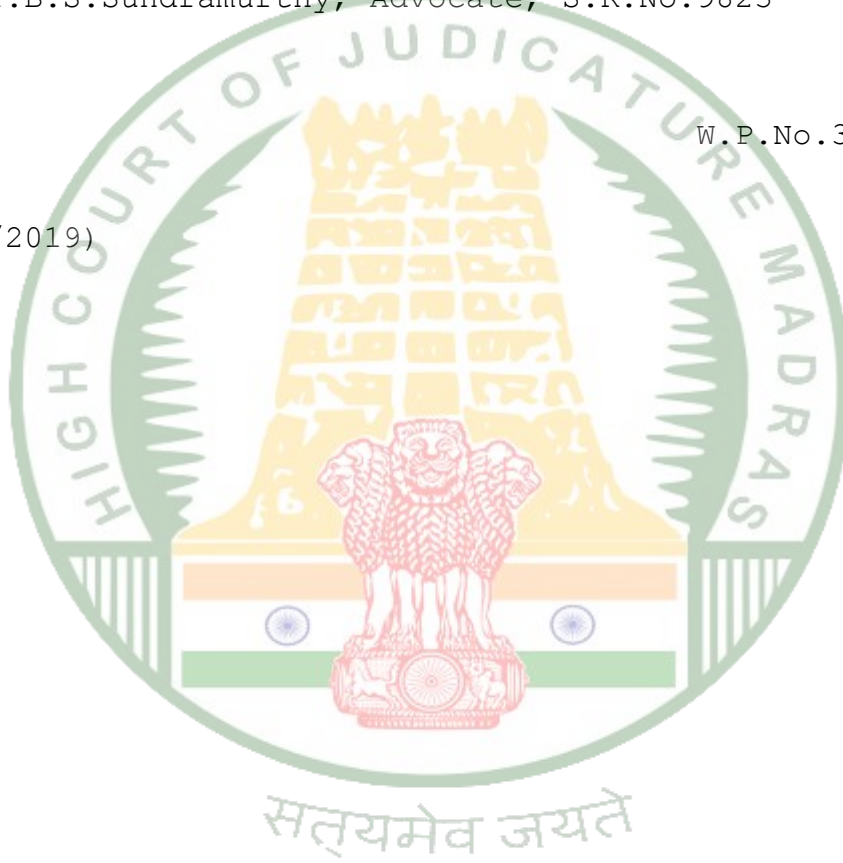
