PRAYER : Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, calling for the records relating to G.O.Ms. No.12/2005/Wel(SCWII) dated 05.08.2005 issued by the 1st respondent and clause 5.1 and clause 5.1.1 of the Information Bulletin 2005-06 for admission to professional courses in Pondicherry, quash the same in so far as it states that the reservation for Scheduled Caste candidates is available only for origin S.C. Candidates and consequently direct the respondents to treat the petitioners as scheduled caste candidates for the purpose of reservation in the matter of admission to professional courses in Pondicherry.
