3.In view of the above submissions made, the petitioner is permitted to approach the fourth respondent under the Street Vendors Act, 2014 within a period of two weeks from the date of receipt of a copy of this order. If any such representation is received by the fourth respondent, the same shall be considered on merits and in accordance with law, as expeditiously as possible.

4.The writ petition is disposed of accordingly. No costs.
