It is also seen that with regard to the same, the petitioner did not make any representation to the concerned police station. 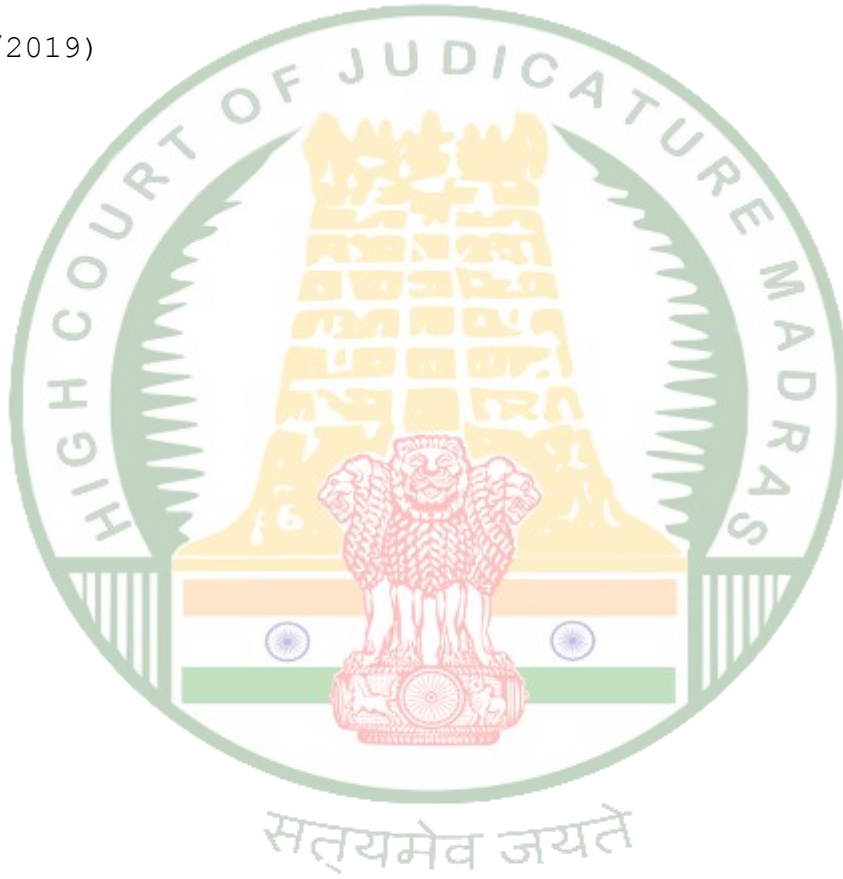
