This Original Petition coming on this day before this court for hearing the court made the following order:

The petitioners seek issuance of succession certificate in respect of the securities left behind by K.Suresh Babu, who died intestate on 14.11.2016 leaving behind the petitioners who are the wife, minor son and mother as his legal heirs.

2. The first petitioner has examined herself as P.W.1. She has produced the death certificate of the deceased K.Suresh Babu as Ex.P1 and the legal heirship certificate as Ex.P2. A perusal of the Ex.P2 shows that the petitioners are the only legal heirs of the deceased. The 3rd petitioner namely, mother had consented for grant of

succession certificate in favour of the first petitioner. Necessary publication has been effected and no objections have been received. The first petitioner also happens to be the guardian of the minor, this original petition is allowed granting succession certificate in respect of the securities mentioned in the schedule to the petition in favour of the first petitioner.
