The learned counsel appearing for the petitioners seek permission of this Court to withdraw these Civil Revision Petitions. He has also made an endorsement to that effect.

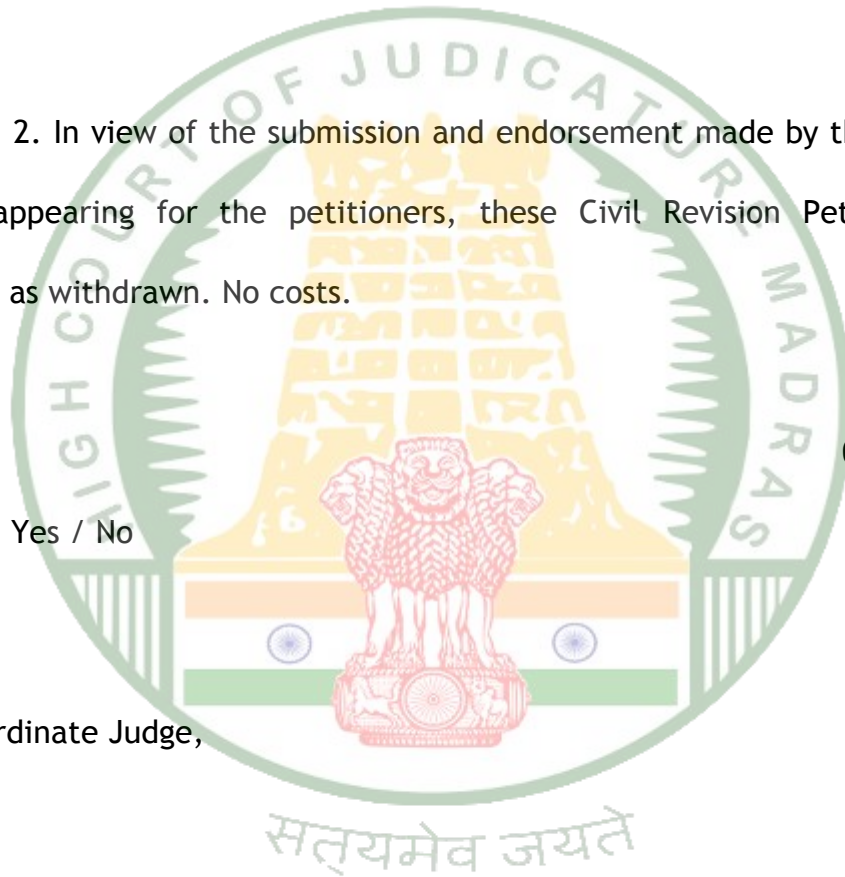
2. In view of the submission and endorsement made by the learned counsel appearing for the petitioners, these Civil Revision Petitions are dismissed as withdrawn. No costs.

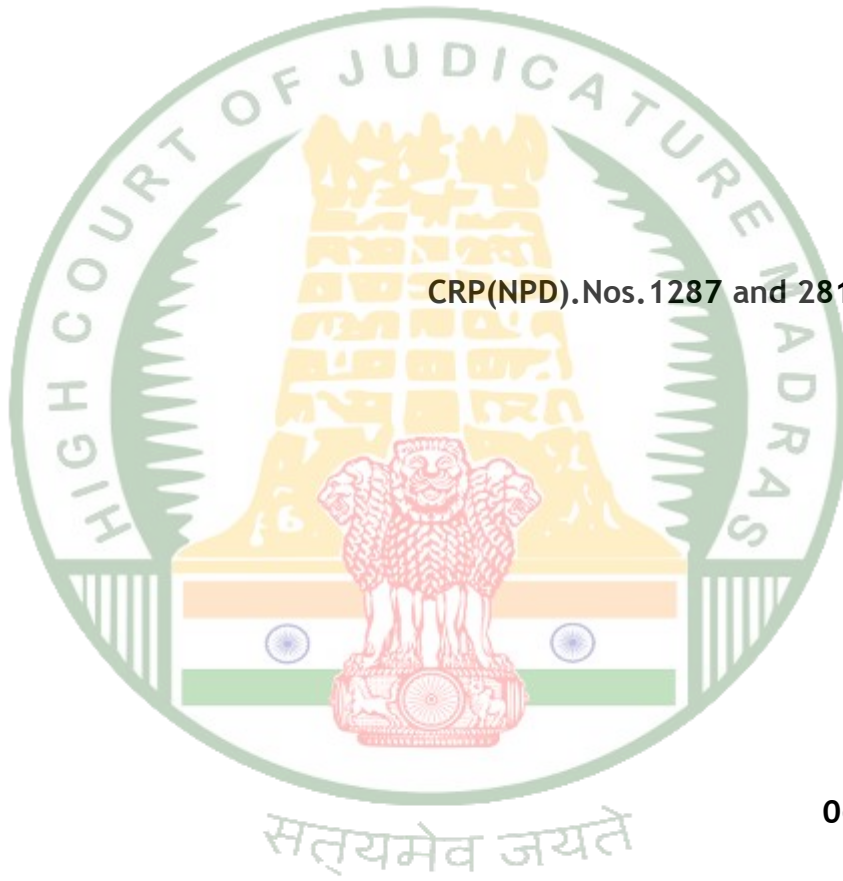
