This Court passed an order on 11.01.2012, which reads as under:-

"The above matter is listed today i.e., 11.01.2012, under the caption 'Default Cases', for non-compliance of the requirements of the Registry, including the payment of batta.

On verification, it is found that the defects notified by the Registry has not been complied with, within the time stipulated in the order dated 11.1.2012. Thus, the writ petition stands dismissed. However, there shall be no order as to costs. Connected miscellaneous petition is closed.
