Heard Mr.B.Sundarapandiyan, learned counsel for the petitioner and Mr.V.Jayaprakash Narayanan, learned Government Pleader (i/c) for respondent Nos.1 to 4.

2. The petitioner is seeking direction to the respondents 1 to 4 to remove the encroachments in the land comprised in Survey No.28/5B - 0.27.0 ares at V.Sithampur Village, National Highways Road, Thirukovilur to Villupuram, Villupuram District and put up bus stop on the said land.

2. The learned Government Pleader (i/c) has produced a letter dated 23.06.2019 of the Revenue Tahsildar, Kandachipuram, wherein it is stated that the said encroachments have been removed. The learned Government Pleader (i/c) further stated that setting up of bus stop on the said piece of land is under consideration by the authorities.

3. In view of the above, no further orders are required at this stage and the writ petition is disposed of. No costs.

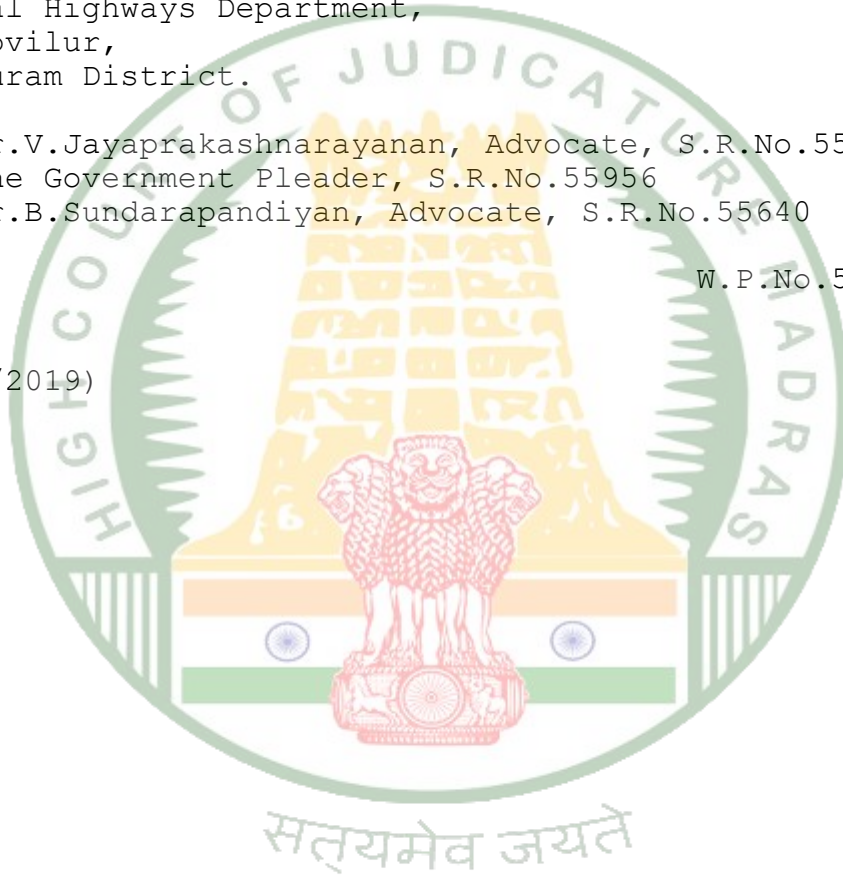
