Prayer in W.P.No.27891 of 2010: Writ Petition is filed under Article 226 of the Constitution of India, praying to issue Writ of Certiorarified Mandamus calling for the records from the 1<sup>st</sup> Respondent relating to his Order in R.C.No.14263/08/M1, dated 25.03.2009 confirming the order of the 2<sup>nd</sup> Respondent made in Ref.No.31 Estt. 1/2008 dated 21.04.2008 and quash the said order dated 25.03.2009 and direct the Respondents to pay the Petitioner the monetary benefits with effect from 07.12.1995 to 30.11.2000 consequent on the re-designation of the Petitioner as Lab Assistant by the 2<sup>nd</sup> Respondent with effect from 07.12.1995 and award costs.

Prayer in W.P.No.26255 of 2012: Writ Petition is filed under Article 226 of the Constitution of India, praying to issue Writ of Mandamus directing the 1<sup>st</sup> respondent to dispose of the petitioner's representation dated 10.08.2012 directing the 2<sup>nd</sup> respondent to pay the monetary arrears of 6<sup>th</sup> Pay Commission and Leave encashment pay etc., and the Gratuity arising out of the order of re-designation dated 21.04.2008 of petitioner's post as Lab Assistant from Lab Attender, with interest.

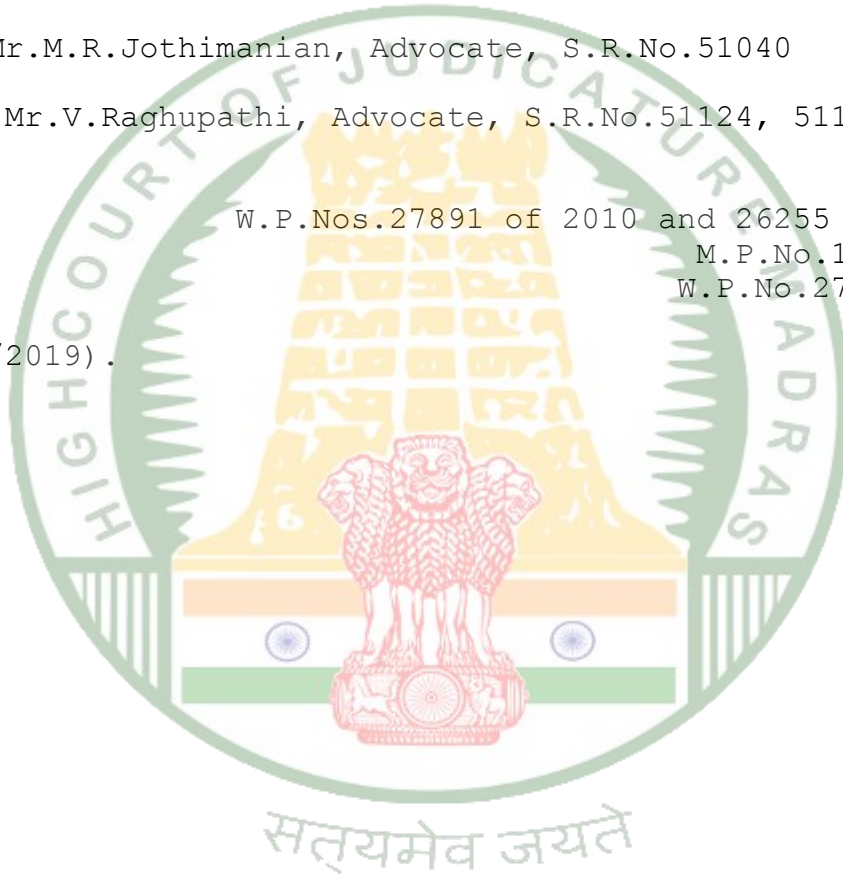
