O R D E R

This petition has been filed seeking a direction, to direct the Principal District and Sessions Court for the Scheduled Castes and The Scheduled Tribes (Prevention of Atrocities) Act at Tiruvannamalai to consider the bail application on the same

day on merits in accordance with law in the event of surrender of the petitioner in connection with Crime No.72 of 2019 pending on the file of the Respondent.

2. In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioner is directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned Special Judge shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.

3. This Criminal Original Petition is disposed of with the above directions.
