This writ petition is filed for a Mandamus directing the respondents 2 to 4 to dispose of the petitioner's representation dated 11.07.2018, wherein and wherein, he sought for permission for establishment of Dheeran Chinnamalai Statue at Plot No.B/3/10/4 Varthampalayam, Sathyamangalam, Erode with Patta No.1562.

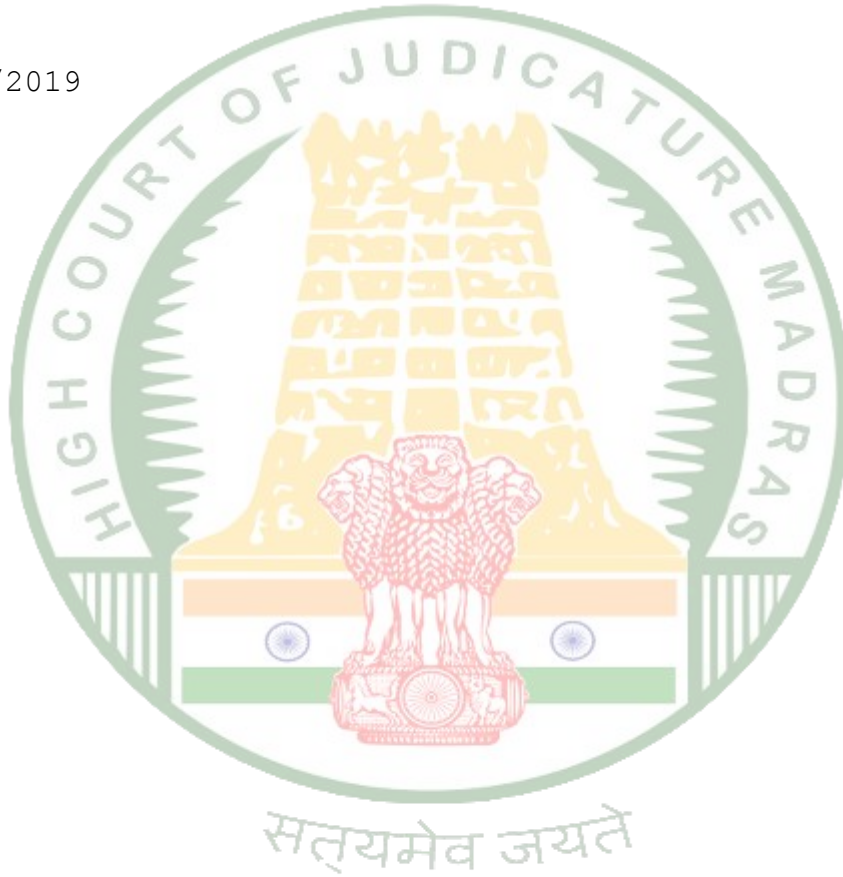
