2. The learned counsel appearing for respondents submitted
that as per resolution passed by the Wakf Board, the election
was over and thereafter two more elections were conducted by the

Wakf Board. Therefore, the relief sought for in this writ petition has become infructuous and nothing survives for adjudication.

3. Recording the said submission made by the learned counsel for respondents, this writ petition is dismissed as infructuous. However, if the petitioner has any grievance in future, it is open to the petitioner to approach the respondents for appropriate action. No costs. Consequently, connected miscellaneous petition is closed.
