Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus, to call for the entire records, relating to the petitioner's husband detention under Tamil Nadu Act 14 of 1982 vide detention order, dated 29.01.2019 on the file of the second respondent herein made in proceedings D.O.No.07/2019-C2, quash the same as illegal and consequently direct the respondents herein to produce the petitioner's husband namely Murugan, S/o.Parvatham, aged 28 years before this Court and set the petitioner's husband at liberty from detention, now the petitioner's husband detained at Central Prison, Vellore.

The petitioner challenges the impugned order of detention dated 29.01.2019 in D.O.No.07/2019-C2, detaining her husband as "Bootlegger", as contemplated under Section 2(b) of the Tamil Nadu Act 14 of 1982.

2. Learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.1069 Home, Prohibition

and Excise (XI) Department, dated 25.03.2019 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition is closed.
