The grievances of the writ petitioner is that on account of his transfer, there was a delay in joining in the transferred post. The entire period was not regulated by the competent authorities for the purpose of extending the service benefits.

2 The learned counsel for the writ petitioner states that the several representations are submitted by the writ petitioner and no action has been taken by the

respondents to regularize the period of leave in accordance with the rules in force. Thus without going into the merits of the matter, the first respondent is directed to consider the representation, submitted by the writ petitioner on 23.02.2018 and pass orders on merits according to law within a period of 12 weeks from the date of receipt of a copy of this order. The writ petitioner is directed to enclose the copy of the representations and all other relevant documents, if any, along with the orders passed in this writ petition.

3 Accordingly, this writ petition is disposed of, however, no order as to cost. Consequently, connected miscellaneous petition is closed.
