2. When the matter is called, the learned Counsel appearing for the petitioner submitted that the prayer in the

writ petition has already become infructuous since Sub-Collector (Rev) South-cum-Land Acquisition Officer has made a reference under Section 18 of the Land Acquisition Act for deciding the quantum of compensation to the District Court, Puducherry on 28.7.2014 itself.

3. Recording the same, the Writ Petition is dismissed as infructuous. No costs.
