This petition has been filed to direct the 2nd respondent to execute the Non-Bailable Warrant issued against the 3rd respondent by the III Additional Family Court, Chennai in M.P.No.545 of 2015 in M.C.No.34 of 2015 dated 12.08.2015.

2. Heard the learned counsel for the petitioners and the learned Additional Public Prosecutor for respondents 1 and 2.

3. It is seen that a non-bailable warrant is pending with the 2nd respondent to arrest the 3rd respondent in M.C.No.34
