2.The learned counsel appearing for the parties has fairly submitted that the petitioner has challenged the appointment and functioning of the fourth respondent both as Collector of Karaikal and Dean in-charge of the third respondent. Now, the Collector of Karaikal has not been appointed as Dean in-charge of the third respondent.

3.In view of the above, nothing survives for adjudication in this matter. Hence, the writ petition stands dismissed as infructuous. However, there shall be no order as to costs.
