secured and produced before the police station and thereafter released. However, subsequently, he was arrested by the Puducherry police in connection with the case in Crime No.164 of 2015 on the file of D.Nagar Police Station, Puducherry.

3.Recording the submission made by the learned Additional Public Prosecutor, this habeas corpus petition stands dismissed.

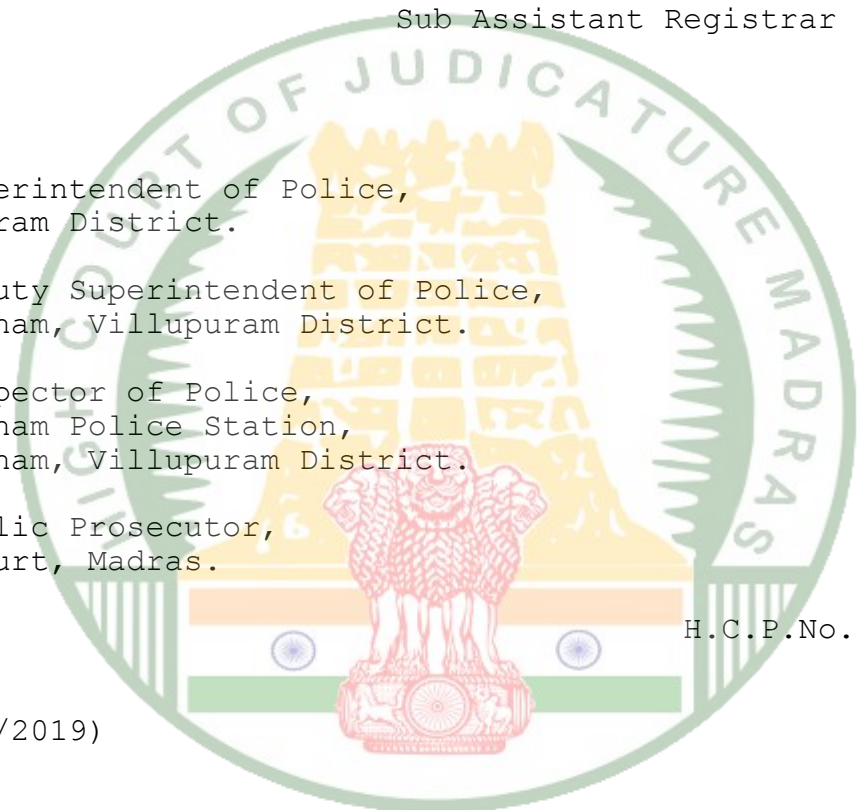
