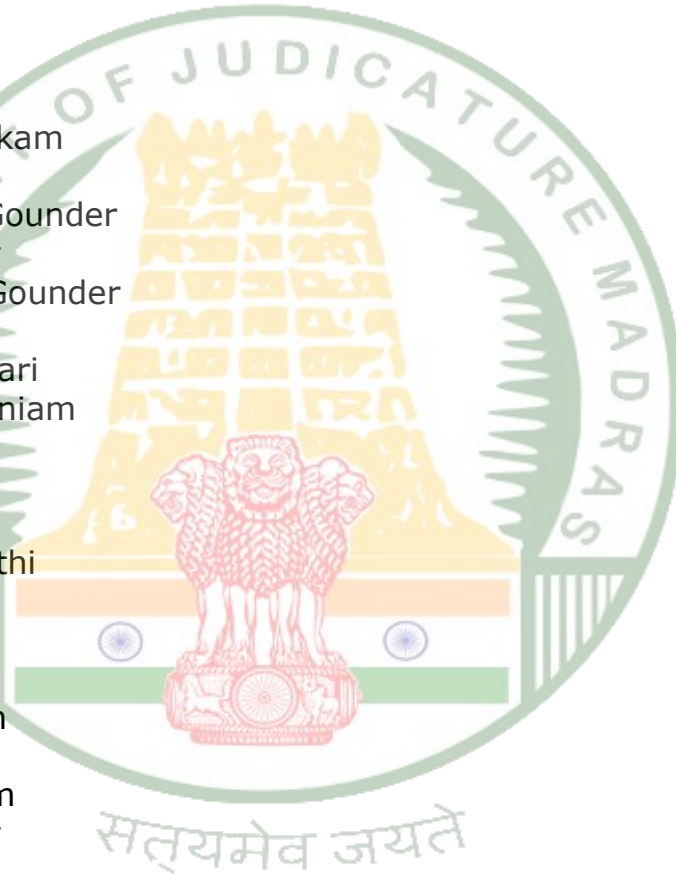

and sought permission of this Court to withdraw these Civil Revision Petitions.

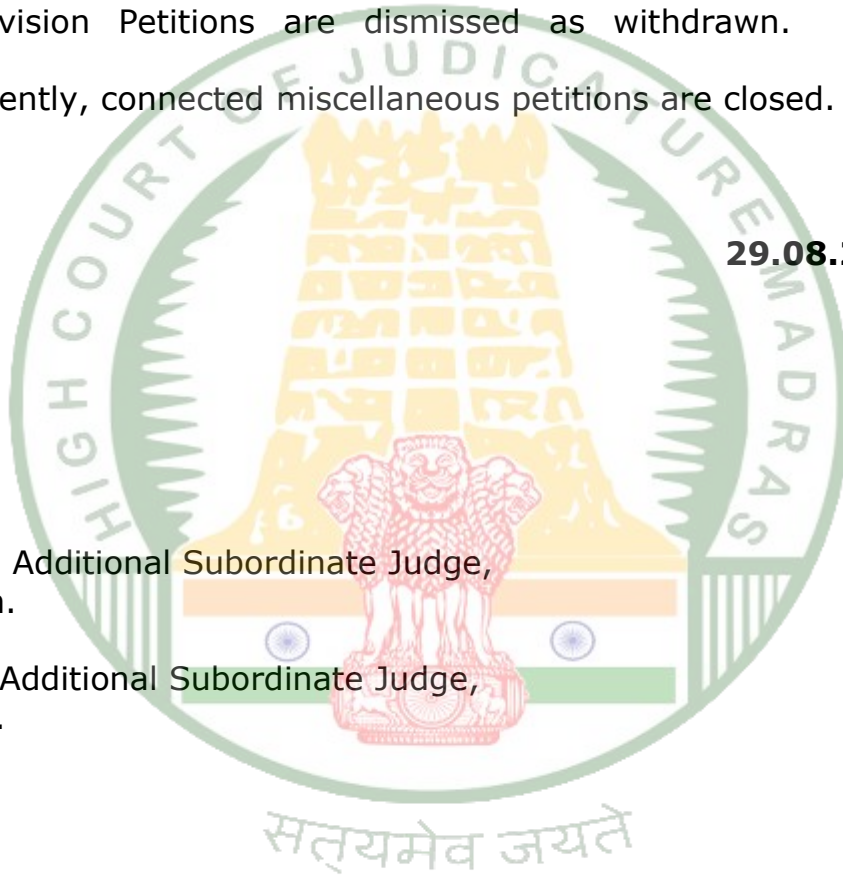
