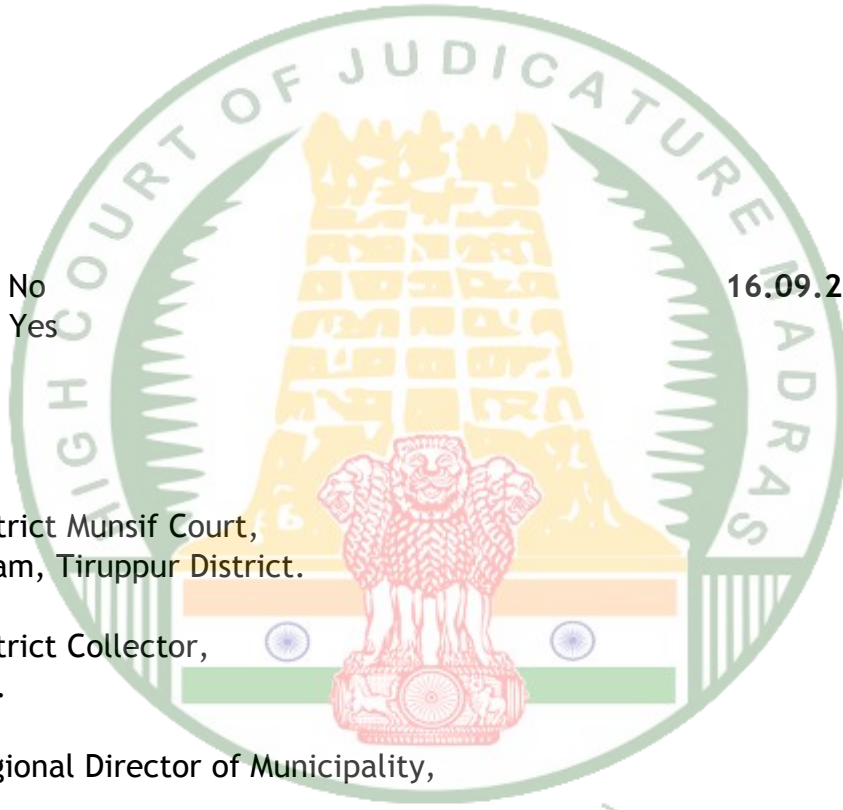
2.In view of the submission made by the learned counsel for the petitioner, the Civil Revision Petition stands dismissed as infructuous. No costs.

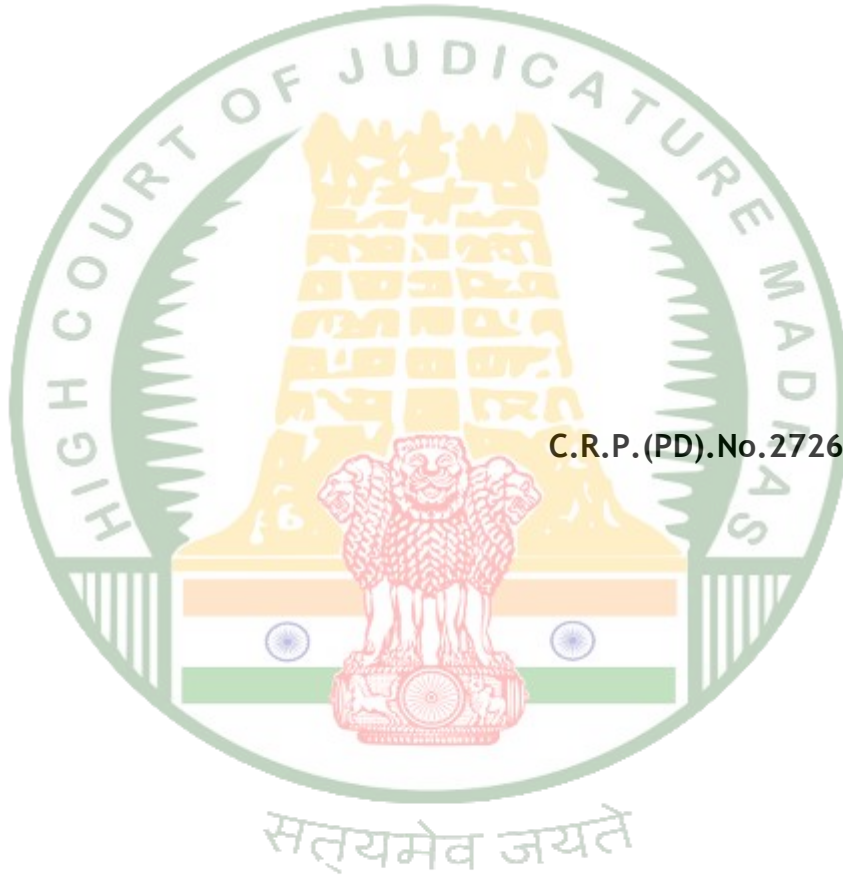
