these Civil Revision petitions have become infructuous.

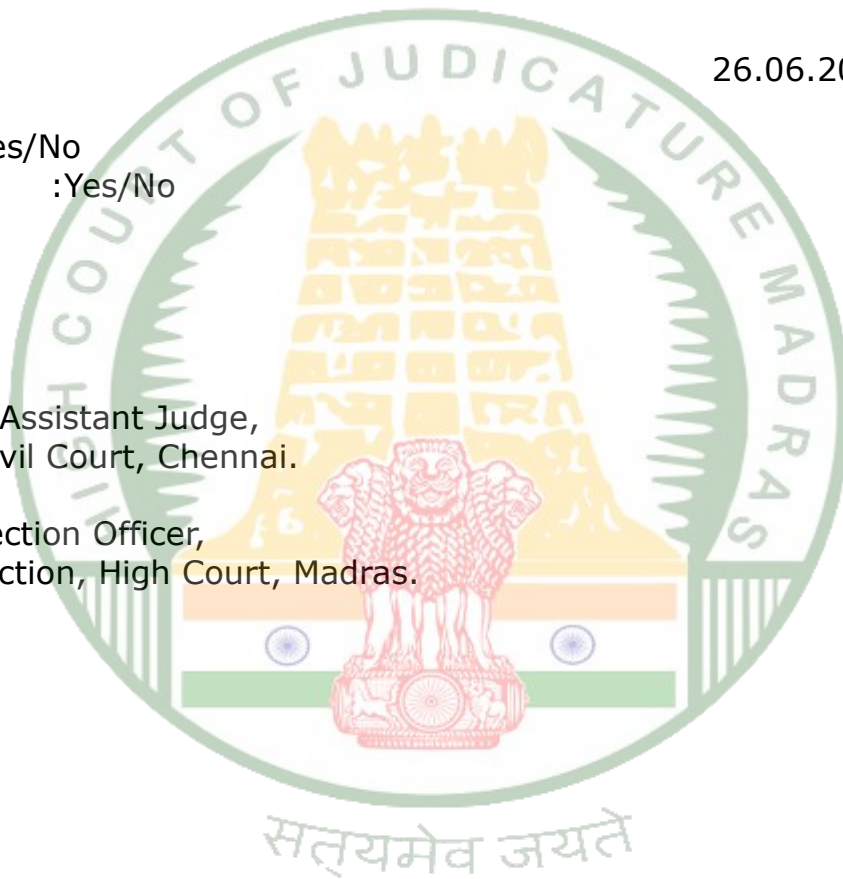
2. Recording the same, these Civil Revision Petitions are dismissed. No costs. Consequently, connected Miscellaneous Petitions are closed.

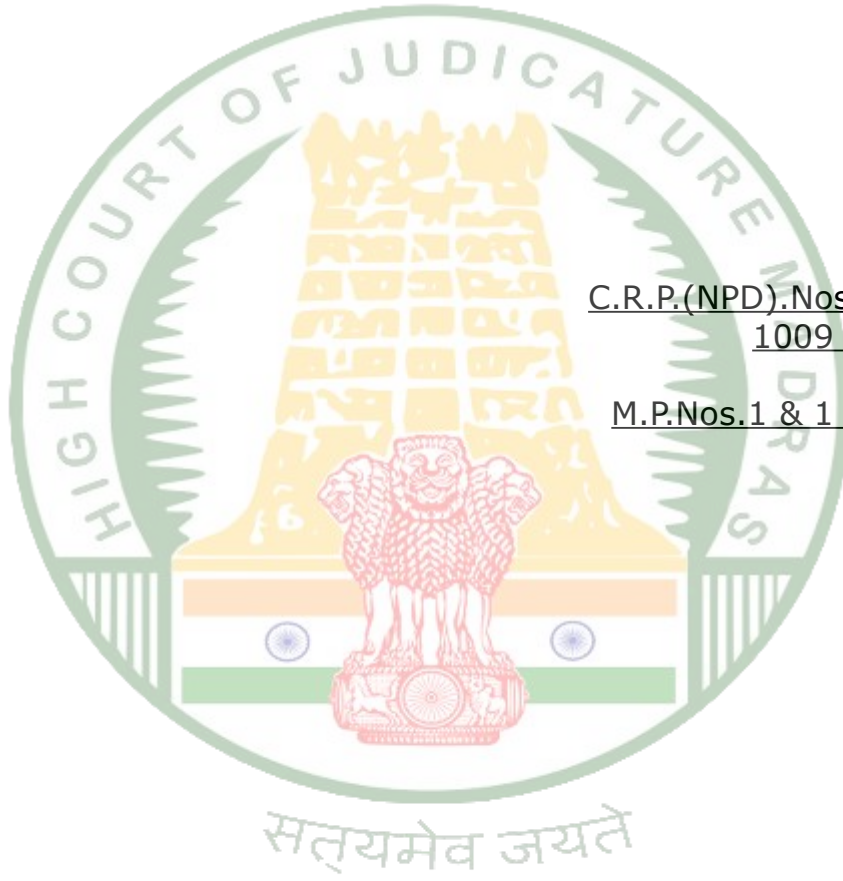
