4. There will be a direction to refund the entire court fee.

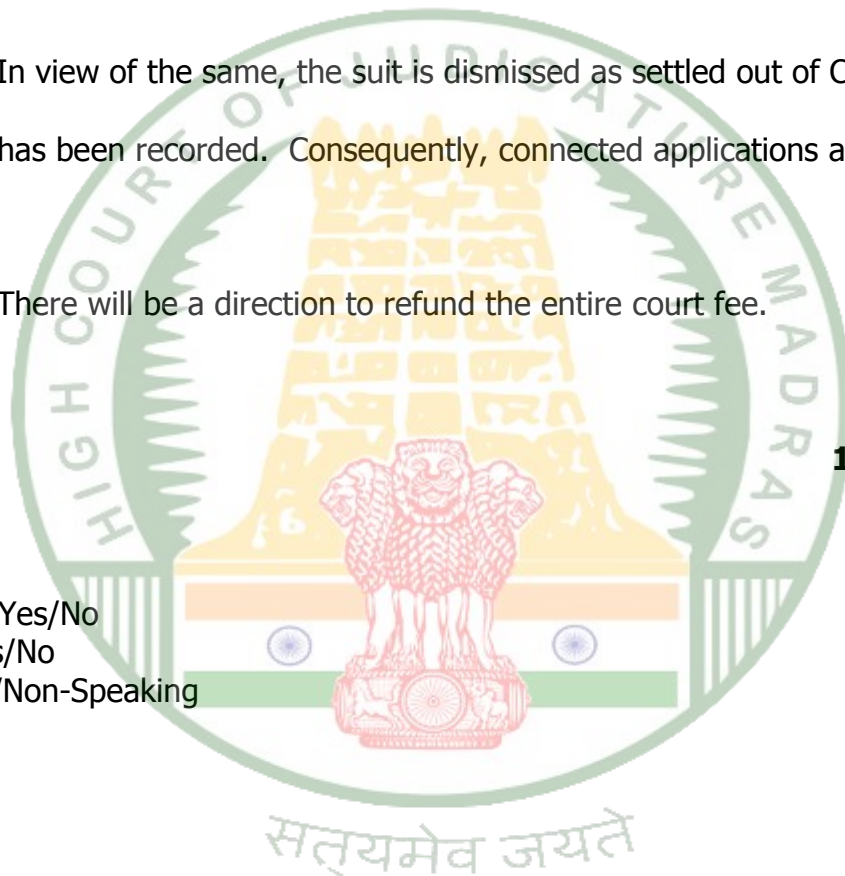
