2. The learned counsel for the Writ Petitioners state that the salary has been paid irregularly and the Writ Petitioners have submitted a representation in this regard to the first respondent to issue suitable orders, directing the second respondent to pay the salary.

Under these circumstances, the first respondent is directed to consider the representation of the petitioners dated 18.11.2017 in W.P.Nos.882, 883, 885 & 886 of 2018 and 04.12.2017 in W.P.No.884 of 2018 and pass orders within a period of 12 weeks from the date of receipt of a copy of this order.

4. The Writ Petitioners are directed to submit the copy of the representations and the documents, if any, along with the copy of this order. Accordingly, these Writ Petitions stands disposed of. No costs.
