fraudulently misused the cancelled power of attorney of the petitioner's mother and grabbed the property of the petitioner's family.

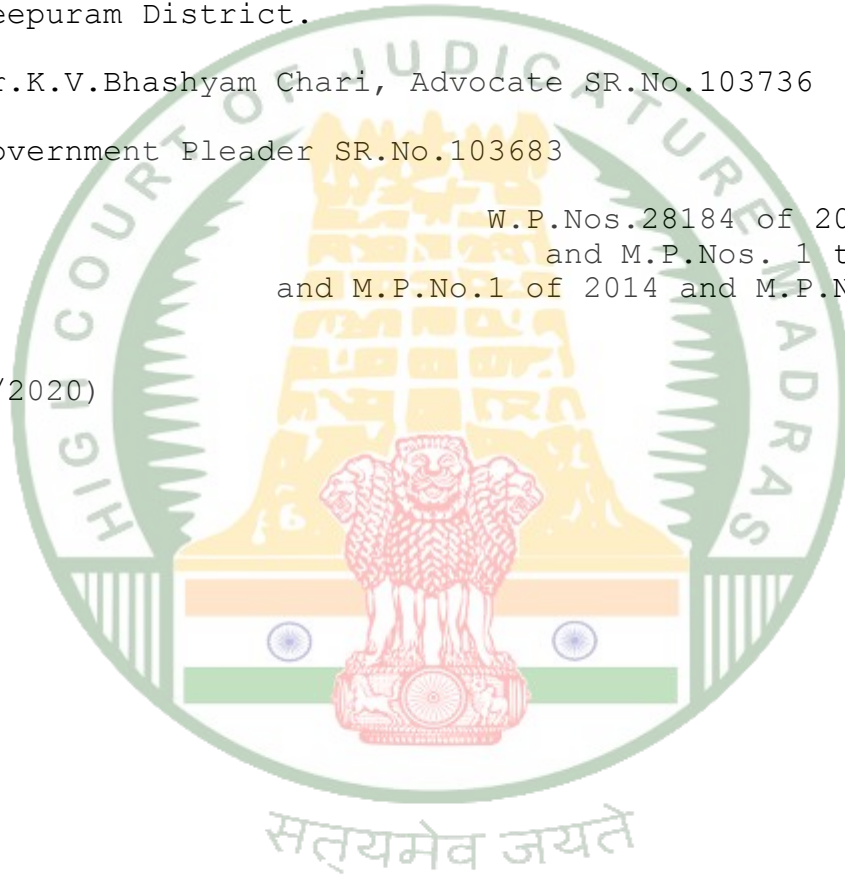
