ORDER

3. The petitioner seeks for a mandamus directing the respondents 1 to 4, particularly, the 2nd and 3rd respondents to

issue patta in favour of the petitioner for the property, situated at Krishnagiri Registration District, Hosur Sub-Registration District, Hosur Taluk in Govinda Agraharam Village, the land bearing SF.No.28/3, Dry Extent Hec.0.37, Asst.1.03 in this extent of Ac.0.47 cents, based on the petitioner's application dated 06.12.2018.

4. The grievance of the petitioner before this Court is that the said application has not been considered by the respondents so far.

5. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the second respondent to consider and decide the same on merits and in accordance with law. Accordingly, this writ petition is disposed of, only by directing the second respondent to consider the application dated 06.12.2018 and pass orders on the same on merits and in accordance with law, after hearing the petitioner and other interested parties, if any. Such exercise shall be done by the second respondent within a period of eight weeks from the date of receipt of a copy of this order. No costs.
