O R D E R

Mr.E.Balamurugan, learned Special Government Pleader takes notice for the respondents. By consent of the parties, the main writ petition is taken up for final disposal at the admission stage itself.

2. Heard both sides.

3. The petitioner seeks for a mandamus directing the respondents to measure and demarcate the property situated at Plot No.12, Sri Sathiya Nagar, No.167, New No.28, Perungalathur Village.

4. Ventilating such grievance, the petitioner has made the applications dated 10.10.2018 and 04.12.2018, followed by the

representation dated 31.1.2018 to the respondents seeking survey of the land. The grievance of the petitioner before this Court is that the said request has not been considered by the respondents so far.

5. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the first respondent to consider and decide the same on merits and in accordance with law. Accordingly, this writ petition is disposed of, only by directing the first respondent to consider the representation dated 31.12.2018 and pass orders on the same on merits and in accordance with law, after hearing the petitioner and other interested parties, if any. Such exercise shall be done by the first respondent within a period of eight weeks from the date of receipt of a copy of this order. No costs.
