It is submitted by the Learned Counsel for the Petitioner that Policies, viz., Max Life Gain Plus 20 bearing Nos. 869382853, 868861774 and 877871871 would be expiring shortly, but Learned Counsel appearing for the Respondent/Insurance asserts that the Policies have already expired.

2. As the expiry of the contract is disputed, any termination of contract shall be subject to the result of this Writ Petition, which shall be mentioned in all proceedings in that regard.
