This contempt petition has been filed as against the respondent alleging that the petitioner approached this Court in CrI.O.P.No.5638 of 2019 to quash the FIR in Crime No.12 of 2018 on the file of the respondent police station.

in Crime No.12 of 2018 in CrI.M.P.No.3202 of 2019 in CrI.O.P.No.5638 of 2019 dated 01.03.2019. Thereafter, without obeying the order passed by this Court, the respondent police conducted investigation and filed a final report on 01.04.2019. The learned Counsel for the petitioner further submitted that the said charge sheet has also been challenged before this Court in CrI.O.P.No.8591 of 2019 and this Court granted stay of all further proceedings of the final report on 03.06.2019.

3. Considering the facts and circumstances of the case, the petitioners are very well at liberty to pursue the quash petition challenging the charge sheet filed by the respondent in CrI.O.P.No.8591 of 2019.

4. In view of the above discussion, the contempt petition is closed.
