The petitioner challenges the impugned order of detention dated 22.02.2019 in BCDFGISSSV No.102/2019 detaining her son as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

2. Learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by

the Government by its order in G.O.Rt.No.1274 Home, Prohibition and Excise (X) Department, dated 08.04.2019 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition is closed.
