2. Heard the learned counsel for the petitioner and learned standing counsel appearing for the respondents.

Today, when the Contempt Petition is taken up for consideration, both learned counsel for the petitioner as well as learned counsel for respondents submitted that the order of this Court had been complied with by the respondents.
