These Criminal Original Petitions have been filed to call for the records in C.C.Nos.13 & 12 of 2011 on the file of the Learned Judicial Magistrate, Kallakurichi and to quash the same.

2. The learned counsel appearing for the petitioner would submit that without going into the merits of the case, it would suffice, if this Court issues direction to the Trial Court to expedite the trial and complete the same as early as possible. He would further submit that the appearance of the petitioner before the Trial Court may be dispensed with and would further submit that the petitioner is ready to appear as and when necessary arise.

5. With the above directions, these criminal original petitions are disposed of. Consequently, connected miscellaneous petitions are closed.
