ORDER

This Criminal Original Petition has been filed seeking for Police protection.

2.It is seen that there is a dispute between the petitioner and his son. S.No.204 and also to harvest the agricultural crops and cultivate the said property, till the completion of the Civil Suits pending between the petitioner and his son.

3.On such undertaking recorded, the respondent Police closed the enquiry in C.S.R.No.128 of 2015. Therefore, the said undertaking is also recorded herein, hence, the Criminal Original Petition is closed.
