The learned counsel for the writ petitioner states that during the pendency of the writ petition, the modified order of transfer has been issued, modifying the earlier order in proceedings dated 27.12.2010. 2.However, in respect of claiming of salary and other benefits, the writ petitioner is at liberty to submit fresh representation by setting out his grievances.

3.The respondents are directed to consider the representation submitted by the writ petitioner with reference to the rules in force and pass appropriate orders as expeditiously as possible including the payment of arrears of salary.

4.Accordingly, the writ petition stands disposed of. No costs. Consequently, connected miscellaneous petition is closed.
