3 In the result, these Civil Revision Petitions are disposed of on the above lines. No costs. Consequently, connected miscellaneous petitions are also closed.

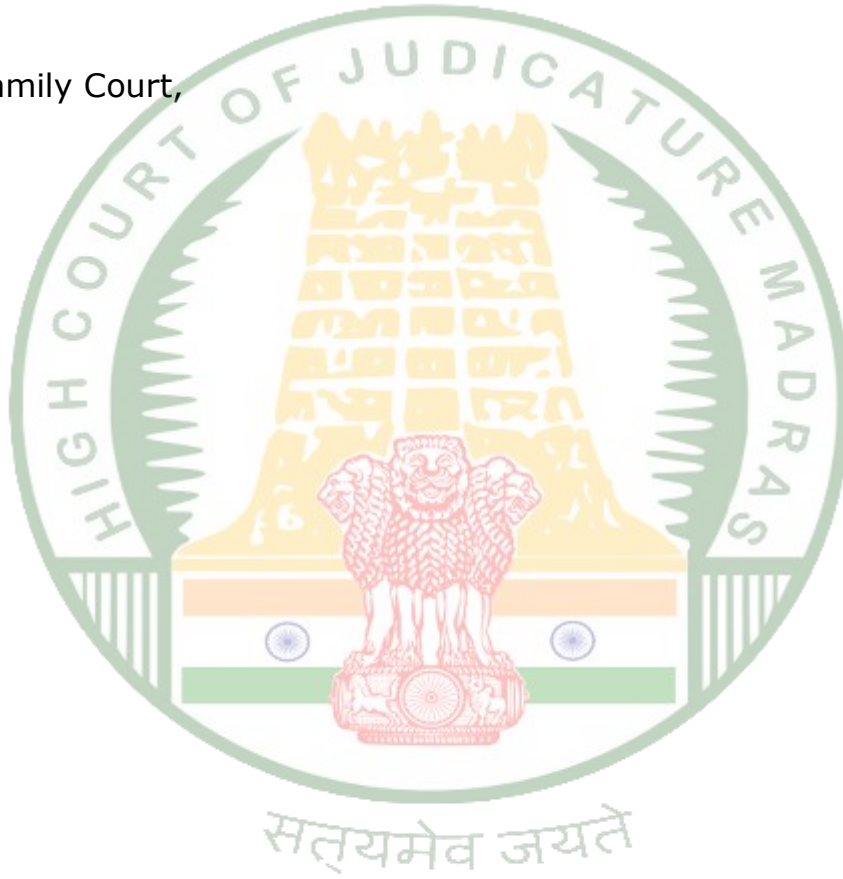

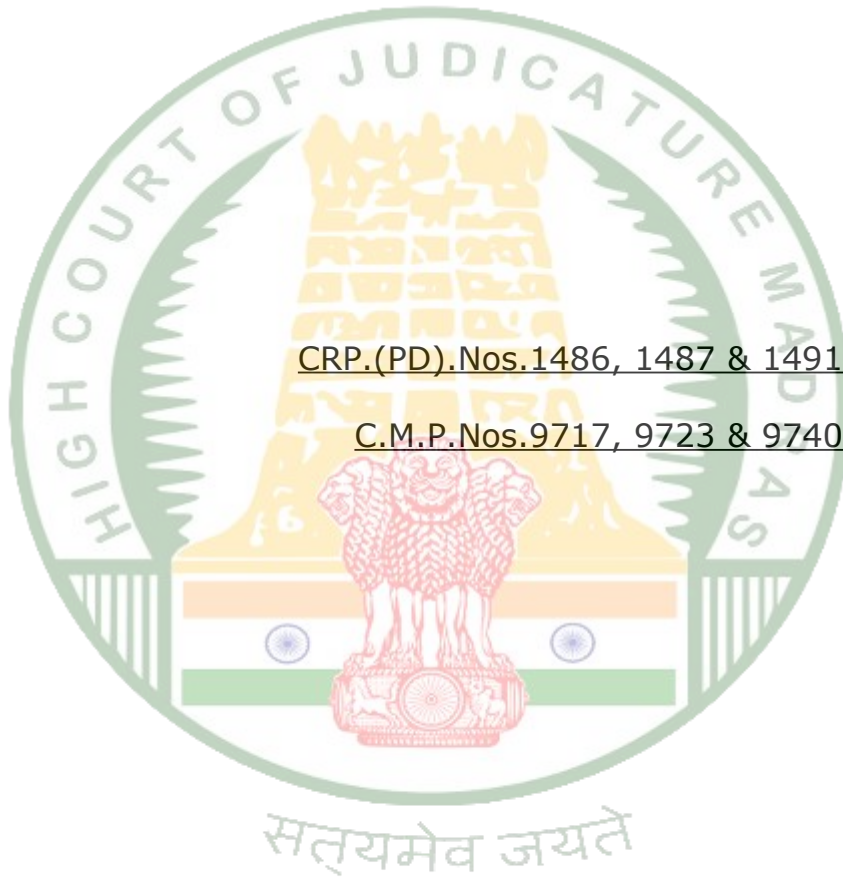
