2. The petitioner seeks for Mandamus directing the 2nd respondent to give permission to conduct cultural and dance programme for the 12th year Chittirai Festival of Selva Vinayagar Temple at S.R.Nagar, Ayyampalaiyam, Palladam Taluk, Tirupur District on 14.04.2019 from 7.00 p.m. to 10.00 p.m.

3. The learned Special Government Pleader, who takes notice for the respondents submitted that already a circular memorandum dated 31.10.2018 has been issued by the Director General of

Police to all the Station House Officers/Inspectors indicating the conditions to be imposed while considering the grant of permission to "Aadal Padal Programme". Therefore, he submitted that the petitioner's representation will be considered by the second respondent in the light of the Circular already issued by the Director General of Police dated 31.10.2018.

4. Recording the above said submission, this Writ Petition is disposed of, by directing the second respondent to consider the petitioner's representation dated 22.03.2019 and pass orders on the same on merits and in accordance with law on or before 10.04.2019 No costs.
