The petitioner seeks for a mandamus directing the 1st respondent to consider and pass orders in the appeal dated 24.12.2018, wherein and whereby, he challenged the order passed by the second respondent granting joint patta in the name of the petitioner and the father's of the respondents 3 to 6.

3. The grievance of the petitioner is that the said appeal has not been considered by the 1st respondent so far.

This Court, at this stage, is not expressing any view on the merits of the appeal filed by the petitioner, as it is for the first respondent to consider and pass appropriate orders on merits and in accordance with law.
