JUDGMENT

(By Dr.Vineet Kothari,J.)

Having heard the learned counsel for the parties, we are satisfied that no interference is called for in the impugned order passed by the learned Single Judge, dated 10.01.2019, in W.P.No.29784 of 2018.

2. The Respondent-writ petitioner, who is a 'Freedom Fighter', is stated to be aged about 96 years.

3. The learned Single Judge has directed the Appellant-State to sanction State Freedom Fighters Pension to the respondent, which Pension is said to be approximately Rs.3,000/- per month now, from the date of his application. The learned Single Judge has discussed all the facts and circumstances of the case and supplied adequate reasons in the impugned order.

4. Therefore, we see no reason to interfere with the order impugned in this Writ Appeal before us. Writ Appeal is, accordingly, dismissed.

5. Compliance of the order of the learned Single Judge be made by the Appellant-State within four weeks from today, in view of the advanced age of the respondent-writ petitioner.

6. No costs. Consequently, the connected C.M.P.No.13160 of 2019 also stands dismissed.
