PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus, to call for the records of the detention order made in B.C.D.F.G.I.S.S.S.V. No.63/2018 dated 30.08.2018 passed by the District Collector and District Magistrate, Kancheepuram District, Kancheepuram, the 2nd respondent herein and set aside the same and direct the respondents to produce the detenu before the Hon'ble Court and set the detenu R.K.Sathish, S/o.Rajkumar aged about 27 years, now confined at Central Prison, Vellore and set him at liberty.

ORDER

The petitioner, who is the mother of the detenu herein, viz., Sathish, son of Rajkumar, aged 27 years, has come forward with this petition challenging the detention order passed by the second respondent by his order in B.C.D.F.G.I.S.S.S.V.

No.63/2018, dated 30.08.2018 against her son branding him as a "GOONDA" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner herein dated 30.08.2018 has been revoked by the Government in G.O.Rt.No.4542, Home, Prohibition & Excise [XI] Department dated 15.10.2018 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this Habeas Corpus Petition is closed as the same has become infructuous.
