This Civil Suit is preferred, under Order VII Rule 1 of CPC read with Order IV Rule 1 O.S. Rules of the Madras High Court, praying to

a) Recovery of a sum of Rs.6.8 crores payable by the Defendants to the Plaintiff and further interest at the rate of 12% per annum on Rs.5 crores from the date of the plaint till the date of realization;

3. In the light of the aforesaid narrative and trajectory, instant suit is dismissed for default/non prosecution. There shall be no order as to costs.

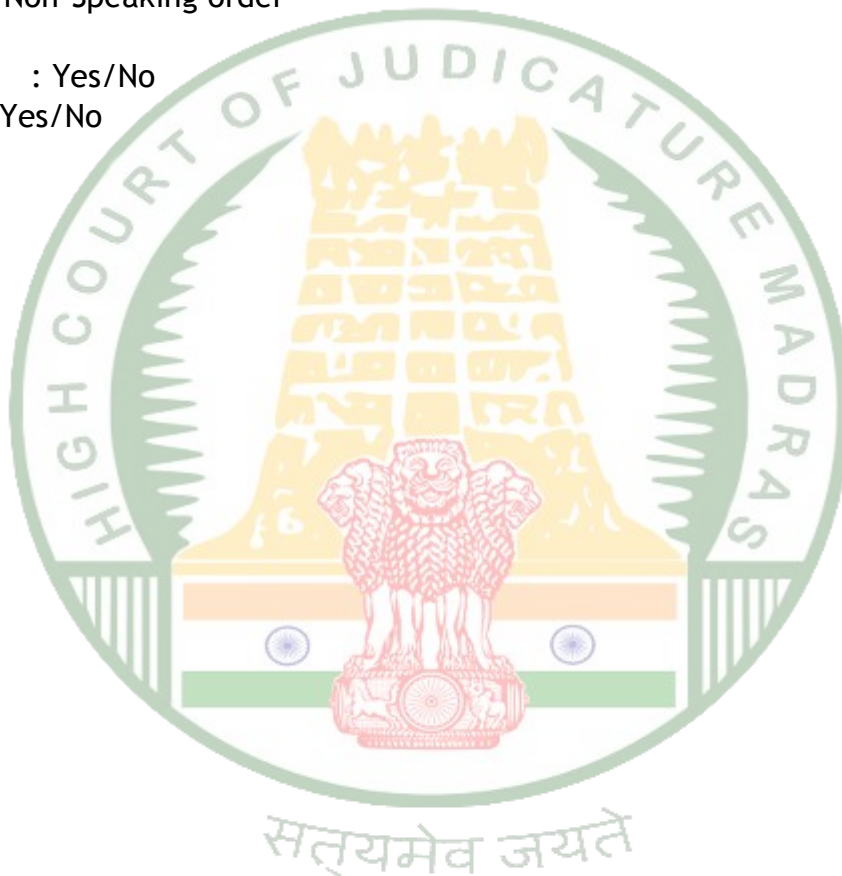

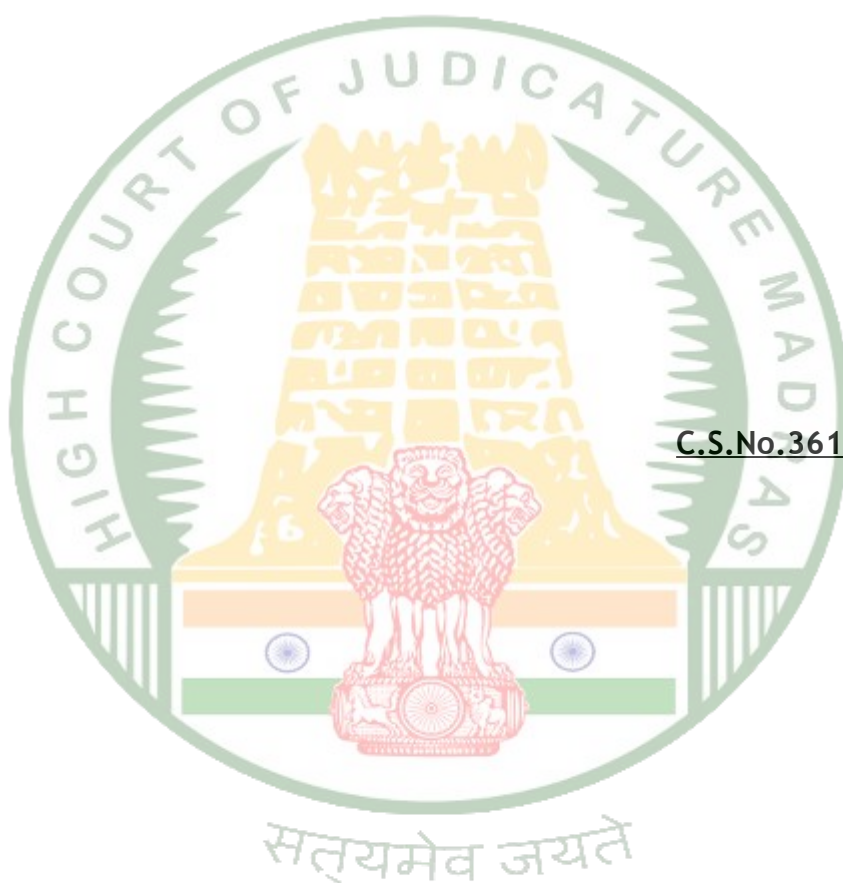
