PRAYER : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Certiorarified Mandamus, calling for the records relating to the Attachment Notice No.302 dated 08.02.2016 issued by the Respondents herein, quash the same as illegal and consequently forbear the respondents from insisting payment on revised rate of property tax.

ORDER

Mr.Salai Varun, learned counsel representing the counsel on record for writ petitioner and Mr.B.Anand, learned counsel for respondents are before this Court.

2. Learned counsel for writ petitioner submitted that a revision petition said to have been filed under Rule 85 of Rules under District Municipalities Act, 1920 has since been disposed of (dismissed on 18.06.2019).

3. Mr.B.Anand, learned counsel for respondents confirms this position.

4. Learned counsel for writ petitioner submitted that he has instructions to withdraw this writ petition, but seeks leave



to preserve the rights of the writ petitioner to assail the aforesaid order dated 18.06.2019 dismissing the revision petition.
