4.According to the petitioner, the election to the said Durgah has not been conducted in despite of his repeated representations. It is seen that the last representation was made by the petitioner on 21.03.2019.

5.The learned counsel appearing for the respondents submitted that such representation will be considered and appropriate orders will be passed by the first respondent.

6.Accordingly, this writ petition is disposed of by directing the respondents to consider the representation of the petitioner on merits and in accordance with law within a period of twelve(12) weeks from the date of receipt of a copy of this order. No costs.
