The petitioner seeks for a mandamus directing the respondents to consider and pass orders on his application dated 13.03.2019, wherein and whereby, he sought for conducting survey and effecting sub-division and transfer of patta in his favour in respect of the land comprised in S.No.111/1, measuring an extent of 1.10 acres situated at Kottioyur Village, Yelagiri Hills, Tirupattur Taluk, Vellore District.

4. The grievance of the petitioner is that the said application has not been considered by the respondents so far.

5. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the second respondent to consider and decide the same. Such exercise shall be done by the second respondent within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
